## **Exemplary Curriculum vitae**

The CV has to be drafted in the language of the dissertation and inserted as the last page. It has to be brief and may cover a maximum of one page. The main purpose of the CV is that the candidate can be clearly identified. Therefore, personal details such as first name, last name and date of birth have to be included in every case. Please leave out any contact details, picture and signature. As a rule, the CV in the dissertation is divided into personal details, education and, if you wish, professional experience. Please leave out further details such as conferences, publications, etc. The CV may be drafted in table form (see example below) or as a text.

### Sample: Bibliographic citation

The bibliographic citation is the exact declaration of how the dissertation or the single papers constituting the dissertation are to be cited. It is not the bibliography of the literature you used in your dissertation. Instead, it is about how third persons shall cite the papers constituting your dissertation. The bibliographic references of papers that have already been published are determined by the publisher. The bibliographic citation is usually provided on the title page of the relevant paper (see example 1). Also for papers that have been submitted, but not yet published, the current status at the time of the printing of the dissertation shall be stated (see example 2).

### Example 1:

A version of this paper / This paper is published as Author 1, Author 2, Title of the paper, Name of the journal, Volume (Issue), Page-Page, Year.

#### Example 2:

A version of this paper / This paper has been submitted to the Name of the journal.

The candidate is responsible for observing copyrights with regard to the publication of all components of the dissertation, both in the context of the dissertation and in any other publications (DO, Sec. 8.3). Please contact the relevant journal in case of doubt.
